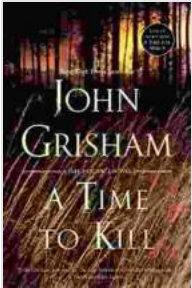

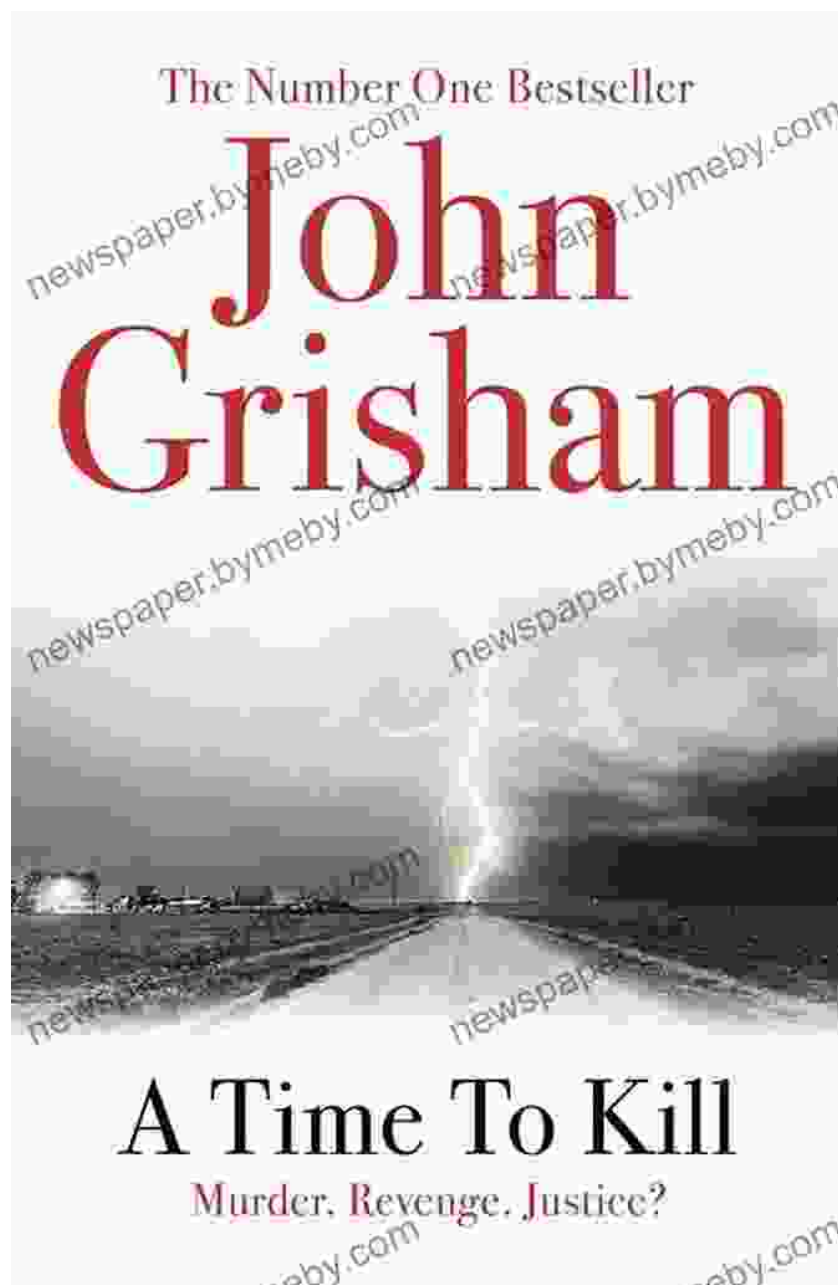

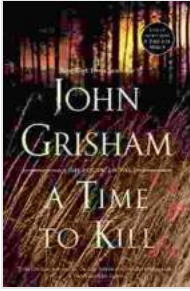

Grisham is a generous supporter of charitable causes. He has donated millions of dollars to libraries, schools, and other organizations. He is also a vocal advocate for the death penalty.

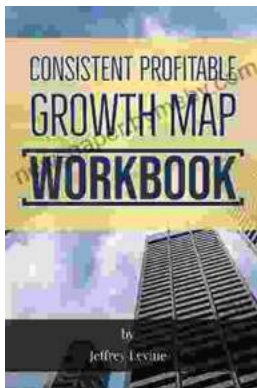

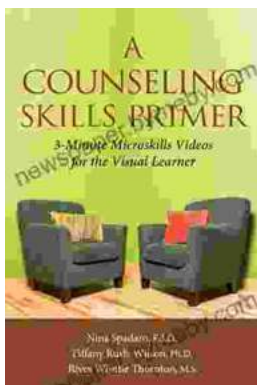
